## **Maximum Capacity For Emergency Evacuation**

The main entrance to the site is over 4.5m which will allow 369/minute (2950 in 8 minutes) to evacuate. We will also be creating extra exits in the fence which will used as a secondary exit(s) route as well. These will be 2 x 1.5m which adds another 246/minute (1968 in 8 minutes). In the event of an emergency the exit capacity flow is more than double that we will have on site. If over crowding is deemed to be a problem by either of the on-site emergency controllers, stewards will restrict the entry of further members of the public. A clear route is available for emergency vehicles around the perimeter of the site.

### The Site

The site consists of a large grassed area (football pitches) and play areas with play equipment. The grass will be cut short prior to the event and any vegetation that could cause a fire risk will be cut and removed.

#### **Communications**

The main organisers including the persons in charge will have walkie talkies and mobile phones on them at all times in case of an incident. The site is also an open field with good line of sight to the majority of all areas, so any problems can be identified quickly.

#### **Permanent Structures**

There is a small permanent structure on the recreation field, the pavilion, with two externally accessed toilets at one end. The building is single storey consists of two changing rooms with showers normally used by the football teams and a storeroom with a sink and tea making facilities. This building will not be open to the public during the event and will be used purely used as a store and by the first aiders. There is a fire blanket and a foam extinguisher located in the entrance to the building. The soft drinks bar, refreshments and lost child gazebos will be in front of the entrance and so will not mean the public can just walk in. There is no gas equipment and the electric immersion heater for hot water is safety checked as part of the recreation grounds normal safety checks.

# Bar, Refreshments, Lost Child Point & First Aid Tents

These consists of a metal frame commercial grade popup gazebos (total 4.5 m x 9m). These will be positioned side to side and in front of the pavilion (the permanent structure) and will only have the left and right side panels at the extreme ends. Table will be placed at the front for serving and only authorised persons will be allowed access. There will be escape route to the rear along the entire structure.

## **Food Vendors**

All food vendors are professional street traders and will supply their own Risk Assessments and hygiene certifications. All will have their own fire fighting equipment and will be sited together with an additional fire station with Foam & Powder extinguishers, a blanket and fire bucket on a trolley very nearby. Sufficient space between vendors will be allowed but no public access to their rear.

# PA Systems

Dan Rossiter will again be supplying, setting up and manning all the PA equipment. He will work with our our Part P registered contractor for connecting to the hired generators sited behind the stage area.

#### Generators

One 20KVA diesel tow-able generator and a 6KVA diesel super silenced generator as a backup. The generators will be fuelled by the suppliers prior to delivery and have sufficient capacity to run the entire night so there will no need for extra fuel to be stored. Cable runs to the stage and lighting tower will be kept to a minimum and will be secured and marked. This area is not accessible to the public. All power cables are supplied by the hire company.

# **Self Powered Lighting Towers**

A pair of lighting towers the other end of the field and by the second toilet block is are self powered tow-able units. These units will be fuelled before delivery and has sufficient capacity to run the entire night with refuelling. All power cables are supplied by the hire companies. All cable runs will be clipped at a height so to avoid damage, trip hazards and tampering.

#### **Portable Toilets**

There will be individual portable toilets and urinal units located next to the pavilion and its lights and pumps will be powered from the pavilion. The units are being hired from Brandons and will have been safety checked prior to delivery and will be installed and setup by the supplier.
